## **Public Policy- Sara Jain**

- The first all private astronaut mission to ISS begins. The new crew composed entirely of private citizens lifted off on April 8<sup>th</sup> and returned from ISS on April 25<sup>th</sup>, after more than two weeks in orbit and splashing down off the coast of Florida in a Space-X capsule.
- On April 13<sup>th</sup> ESA ended lunar cooperation with Russia. The European Space Agency took another step towards ending cooperation with Russia following its invasion of Ukraine. In addition to terminating its role in the ExoMars mission, ESA now is withdrawing from three Russian robotic missions to the Moon and turning to NASA and commercial partners to get the ESA hardware to the lunar surface.
- NASA Administrator Bill Nelson appeared before a US Senate Appropriations subcommittee on Tuesday to discuss NASA's budget request for the upcoming fiscal year. Then, quite unexpectedly, he dropped a bombshell. After his opening remarks, Nelson was asked what, in his opinion, was the biggest threat to NASA's goal of landing humans on the Moon by 2025. Nelson responded that

the agency needed competition in its program to develop a Human Landing System. In other words, he wanted Congress to support NASA's request for funding to develop a second lander alongside SpaceX's Starship vehicle. But Nelson didn't stop there. He said Congress needs to fund this lander contract with a fixed-price award, which only pays companies when they reach milestones. This contracting mechanism is relatively new for the space agency, which traditionally has used "cost-plus" contracts for large development programs

Nelson said, "I believe that that is the plan that can bring us all the value of competition," regarding fixed-price contracts. "You get it done with that competitive spirit. You get it done cheaper, and that allows us to move away from what has been a plague on us in the past, which is a cost-plus contract, and move to an existing contractual price."

NASA is asking the public to comment on an environmental assessment for its Mars sample return effort. The project, a collaboration with the European Space Agency (ESA), aims to bring to Earth samples gathered by the Perseverance Mars rover, perhaps as early as 2033. Once they're here, scientists in labs around the world will scrutinize them for signs of Mars life and clues about the Red Planet's evolutionary history. Comments are due May 15 either or by mail. The agency also plans to hold two virtual public meetings. The meetings will be Wednesday (May 4) at 3 p.m. EDT (1900 GMT) and Thursday (May 5) at 8 p.m. EDT (0000 GMT on Friday, May 6).
