Introductions

David Korsmeyer

- We are currently in Stage 2, we are allowed up to 50% of staff on site and we are managing this
 through the organizational directorates. Ames is well below the cap, so we have room to bring
 staff on site as needed.
- Agency is planning to move to Stage 1. Correspondence was sent out giving 30-day notice that in
 no fewer than 30 days that NASA will be at stage 1 and occupancy will go up to 75%, beginning in
 April.
- We are still under Federal Mandate for mask requirement. State of the Union stated masks will
 no longer be required, but implementation has not been delegated down to Centers so masks will
 still be required despite County guidelines.
- Ames and the Agency are leaning in to being proactive in maximizing telework. Ames believes on average across the Center this will be 30-40%. The goal is not to push people offsite, but permit people to exercise a greater level of telework.

Kurt Straub, New Ames Procurement Officer

- Kurt has been with NASA for 35 years, started as a Co-Op in college and will remain Procurement Officer for Glenn
- There have been a lot more extensions of current services than we are used to seeing and some of that is due to the Enterprise Solutions not being up and ready. It takes time to combine requirements (both at divergent Centers and locally) and there are different factors at play.
- Kurt is looking forward to visiting in person, and meeting with members of the Contractor Council when he travels out to Ames.

Christine Munroe

- Christine Munroe is the Ames/AFRC Small Business Specialist and supports both Contractor Councils.
- February Small Business Metrics:
 - Agency: We are meting the Small Business goal, but behind in the SDB, WOSB, HUBZone and SDVOSB
 - Ames: We are behind in our Small Business and HUBZone goals, but ahead on our SDB, WOSB and SDVOSB goals.
- Small Business Technical Advisor: Carlos Torrez
 - Assists the SBS in determining the extend to which small business can perform on upcoming contracts
 - o Provides input on establishing small business subcontracting goals in large procurements.
 - Helps clarify technical requirements or terms in contracts that are not initially understood by the Center SBS
 - Gives independent advice to SBS based solely on technical knowledge, experience and expertise

- For Small Business Awards, work with your COs early. Nominations come out in August. Applications need to go from the CO to Christine and be submitted prior to the deadline

Public Policy- Sara Jain

- A test countdown for the first launch of NASA's Artemis I system is still on track for March. NASA officials said the vehicle will roll out of the Vehicle Assembly Building at Kennedy Space Center on March 17 for a full-up test prior to an un-crewed flight around the Moon. The actual Artemis I launch date is dependent on how well the test goes, but the long-awaited launch of the Saturn V-class rocket is getting closer.
- President Biden and U.S. allies announced new sanctions against Russia following its invasion of Ukraine. Among them are further export controls, but NASA says they will not affect U.S.-Russian civil space cooperation. That includes operations of the International Space Station.
- Russia's invasion of Ukraine continues to rattle space cooperation. The European Space Agency September launch of its Mars rover as part of the Russian-European ExoMars 2022 mission is "very unlikely." NASA's head of space operations, Kathy Lueders, expressed confidence that the ISS partnership will transcend the current geopolitical crisis. She spoke at a press conference in advance of the launch of the first private astronaut crew, Axiom-1, to the ISS, scheduled for March 30. No changes are anticipated for that mission or the return of three ISS crewmembers from the ISS the same day.
