## **Imagination Foundation – David Cornelius and Linda McCahon**

### **Public Policy- Sara Jain**

- International cooperation on and around the Moon as part of the Artemis program is taking a step forward with the signing of the Artemis Accords between NASA and several partner countries (Australia, Canada, Italy, Japan, Luxembourg, United Arab Emirates, United Kingdom, and the United States of America). NASA Administrator Jim Bridenstine said, "With today's signing, we are uniting with our partners to explore the Moon and are establishing vital principles that will create a safe, peaceful, and prosperous future in space for all of humanity to enjoy." While NASA is leading the Artemis program, which includes sending the first woman and next man to the surface of the Moon in 2024, international partnerships will play a key role in achieving a sustainable and robust presence on the Moon. Mike Gold, NASA Acting Associate Administrator for International and Interagency Relations, said it best "The Artemis journey is to the Moon, but the destination of the Accords is a peaceful and prosperous future."
- On October 21, 2020 President Trump signed the PROSWIFT space weather bill into law, but an accompanying signing statement expressed a number of caveats. Not only does the President consider certain sections to be a limitation on his discretion to conduct foreign affairs, but he also objects to what he calls the bill's failure to address the resilience of national security assets or critical infrastructure. President Trump noted, "Without ensuring the resilience of these assets, our Nation will remain vulnerable to the effects of space weather, regardless of how accurate forecasting becomes."

### Safety Outreach- Mike Weiss and Linda McCahon

- There is a new Code Q interim directive about the requirements for face masks, detailing the specific types of masks you can use on Center and the types of masks that have been deemed unacceptable (bandanas, handkerchiefs, towels, face shields, etc.).
- Most employees are observed wearing their masks, except when alone in their office and that is the only time they should be without their mask.
